
The Trust created by the Author of the Trust is not and shall not be revocable at the instance of the Author of the Trust at any time and under any circumstances.

5. NUMBER OF TRUSTEES:

6. TERM OF OFFICE OF THE TRUSTEES:

These Trustees shall hold office for the duration specified by the board of trustees.

7. GENERAL

- a) The trust and trust property shall be managed by trustees.
- b) The Author of the Trust hereby appoints, constitutes and nominates the Board of Trustees consisting of himself
- c) The Author of the trust shall be relented herein as the Founder Trustee.
- d) The other parties shall be herein referred to as Managing Trustees and Board of Trustees.
- e) The Founder Trustee shall chair all the Meetings of the Board and/or any committees formed by the Board
- f) The Trust does not hold any movable or immovable property during the time of registration.
- g) The Board of Trustees and the Managing Trustee may delegate all or any of the powers vested in them to such person for such time as he/they may deem fit and may revoke, vary, alter, or rescind such powers so delegated.

8. MANAGING TRUSTEE:

With a view to carrying out the objects of the Trust hereinabove mentioned and to augment its funds and to administer them and in the discharge of their duties, without prejudice to the generality of any powers hereby or by law conferred or implied or vested in them as Trustee, the Managing Trustee shall have the following power.

- iii. The Managing Trustee shall perform all functions, and discharge such duties as or specifically entrusted to him/her in writing by the Founder Trustee
- iv. Till the appointment of the managing trustee the founder trustee shall act as the managing trustee.

9. VACANCIES:

- a) Whenever a Trustee shall during the continuance of his office becomes disqualified to hold the office of Trustee, the Board shall issue a notice to the concerned Trustee and after such enquiry shall declare the vacancy stating the grounds of such declaration and the vacancy shall be filled as per the approval of the board of trustees.
- b) The Founder Trustee cannot be removed from the Trust unless he resigns from the office himself.
- c) Any other trustees can be removed from the Trust by the Founder Trustee without assigning any reason.
- d) After the lifetime of the Founder Trustee, any trustee can be removed from the Trust by the decision of the majority of the Board
- e) The office of a trustee shall become vacant by resignation, death or otherwise on the part of the Trustee and notification of the same to the Board.
- f) Any Member of the Board, other than the Founder Trustee, who fails to attend five consecutive Board Meetings shall cease to be a member but can be re-appointed in accordance with the approval of the Board of trustees.

10. TERMINATION OF OFFICE OF THE TRUSTEES:

- a) Trustee shall cease to hold office:
- i. if he dies,
- ii. if he resigns,
- iii. if he is adjudged insolvent or found guilty of an offence involving moral turpitude.
- iv. If he is found to have acted against the interest of the Trust.
- v. if it is unanimously decided by the Trustees specified in para (4) above that his continuation in the Office is against the interest of the Trust.



11.MEETING AND PROCEEDINGS OF THE TRUSTEES:

The Trustees shall ordinarily meet once a month or as often as may be necessary for the satisfactory conduct of the affairs of the Trust.

12.NOTICE:

14 days' Notice shall ordinarily be given in writing for a meeting of the Board of Trustees.

13.QUORUM:

The Quorum for the Meeting of the Board of Trustees shall be 4 numbers of quorum required for a meeting adjourning for want of Quorum.

A minute book shall be kept by the Managing Trustee. Minutes of entry into the office of every new trustee and of all proceedings of the meeting of the board of trustees shall be entered in the minute book and shall be signed by the President of the Meeting.

14. VOTING:

Decisions of the Board of Trustees may be made at a meeting or by circulation of papers to them. Normal matters of routine nature may be circulated and decisions obtained. The important matters are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. The Author of the Board of Trustees shall have a casting vote in the event of an equality of votes, in addition to his own.

15. POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:

(a) All property of the Trust Movable or Immovable or of any other kind shall vest in trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.

- v. (v) To award scholarships and make donations calculated to promote the objects of the Trust.
- vi. `(a) To enter into contracts, or engagements on behalf of the Trust.
- (b) To consider such proposals submitted by Subcommittee appointed by this trust and allocate such funds, if necessary, as deemed necessary for the implementation of the programs.
- vii. To make, sign and execute all such documents and instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust
- viii. To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.
- ix. To sell, transfer or otherwise dispose of any immovable property of the trust provided all the trustees unanimously resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable. properties of the Trust.

- x. To appoint a Committee/Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.




